Who are you—which organization do you represent? What does your organization do?

Vyšší odborná škola zdravotnická, Střední zdravotnická škola a Obchodní akademie, Trutnov has 104 employees and 720 students. The secondary medical high school offers four study programmes: Medical Lyceum, Practical Nurse, Nutrition Assistant and Masseur in Healthcare. All studies are 4-year studies and they are finished by Maturita (school-leaving) exam. The higher medical school offers one branch: A General Nurse (with diploma). The Business Academy offers a 4-year secondary education. Our students are also involved in the activities of the Duke of Edinburgh's Foundation, where they carry out their tasks and meet the set goals. The school intensively supports the talented students, the students with limited opportunities to study, the students coming from socially deprived background, those living with a single parent and the students with a health handicap. All these groups of students have been worked with focus on their individual needs in education.

Where will the project (the visits) take place?

This project is going to take place in three schools in the Czech Republic, Slovakia and in Poland. The participants are two high schools with higher vocational school (Czech Rep. and Slovakia) and one university (Poland). The project activities are planned to take place directly in the partner schools and their partner health care institutions.

Partner organization(s):

Karkonosze Academy of Applied Sciences in Jelenia Gora is University which is based on preparing graduates for professional work, guided by respect for human rights and its values as well as the principles of the culture of interpersonal relations. The University provides free education at Master's studies: physiotherapy and nursing and bachelor's studies in the fields of: dietetics, and social communication, pedagogy, nursing, physical education., Secondary medical school of St. Elizabeth in Košice was established in July 1991 with the support of the then Ministry of Health of the Slovak Republic, out of the great desire of the medical public, parents and the wider public, and the need to educate a selfless, assertive and empathetic nurse for the health sector to serve sick people.

What is the project about? What kind of activities are you planning with your partner(s) during the visit(s)?

The project focuses on developing key competence of the students and teachers of nursing in the participating schools. The objective of the project is to get an overview of how nursing is taught at schools in neighboring countries, the way practical hospital training is organized and the way duties and competence of nursing staff differ in those countries. We know that there are differences in nursing procedures in the participating countries as we have learnt in our previous projects. Since the students of nursing frequently seek job in neighboring countries, it is essential for them to be familiar with these procedures and with the work environment in health care institutions in neighboring countries. We plan to visit lessons of nursing, spend a day at a hospital training and excursions to a health care institution with a very specific type of nursing care (palliative, home care, etc.) during the mobilities. A presentation with overview of differences in nursing procedures is the outcome of the mobility. Online presentation will be placed at websites of each school so it is accessible to professional and lay public. 5 students of Practical/ General Nurse and 2 teachers of professional subjects from each school will participate in each mobility. The students are between 17 and 21 y.o. – those who attend hospital training. Further, approx. 60 people from all schools will be participating. Those students and teachers will participate in mobility activities with the guests
